I. NAME OF SPONSOR(S)

710 ESPN Radio, KSPN, its licensee ABC Radio Los Angeles Assets, LLC ("710 ESPN"); Bubba Burger, Southern California Chevy Dealers and Geico and others TBA (Hereinafter collectively referred to as "Sponsors").

II. ELIGIBILITY

Entrants must be a legal resident of the United States, 21 years of age or older at time of entry and are registered members of ESPNLA.com.

ESPNLA'S 2011 FANTASY FOOTBALL CHAMPIONSHIP will consist of ten leagues consisting of 10 teams each. Each league will host a 13-week regular season, followed by a 4-week head-to-head playoffs where a league champion will be crowned in each individual league; however, the ESPNLA 2011 FANTASY FOOTBALL CHAMPIONSHIP Grand Prize winner will be determined at the end of week 17 according to the overall standings on **ESPNLA's 2011 Fantasy Football Championship Leaderboard**, which ranks teams from among all participating leagues according to head-to-head record, total points, strength of schedule, and other factors according to ESPN.com's Prize-Eligible Standard League Leaderboard method. The leaderboard will be updated throughout the season and accessible via the 710 ESPN page at ESPNLA.com.

The draft order for each league will be randomly selected onsite Sunday, August 28, 2011 at ESPN Zone at L.A. LIVE, 1011 S. Figueroa St., Los Angeles, CA 90015., Los Angeles, CA 90015. Officially registered participants will be those considered registered online at www.ESPNLA.com and notified by 710 ESPN prior to the event. Participants will be randomly assigned a league on site. The official ESPNLA Fantasy Football Championship facilitator will announce to owners when the countdown has reached 15 seconds, then 10 seconds, then five seconds and a countdown from 5, 4, 3, 2, 1 will follow. If a team fails to make a draft selection in 60 seconds, the team due up next will move up one spot and have 60 seconds to make their pick. After that pick, the team passed will be up again and have 60 seconds to make their pick. Owners can pick players at any position throughout the draft, but must have at least one required starter at the 9 starting spots (1 QB, 2 RB, 2 WR, 1 Flex (WR or RB), 1 TE, 1 K, 1 D) by the end of the draft. Points are accumulated from player's 9 starters each week and the team with the most points in the weekly head-to-head match-up is declared the winner.

In the event the winner is deemed ineligible, fails to comply with contest procedures, or is not available to claim prize during specified dates, then an alternate grand prize winner will be selected in accordance with the ESPNLA 2011 Fantasy Football
