

OFFICIAL SWEEPSTAKES RULES

"All Star Game" Sweepstakes:

I. SPONSOR

ABC Radio Los Angeles Assets, LLC, licensee of KSPN-AM Los Angeles, Inc., (Hereinafter collectively referred to as "Sponsor").

II. ELIGIBILITY

Sweepstakes are open to all legal California residents ages 21 years or older at the time of entry.

Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for KSPN-AM, any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the sweepstakes or supplying the prize, and their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, are not eligible to enter or play. "Immediate family members" shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses. Entrants must text the keyword "STAR" to shortcode 4-0-7-0-5 to be qualified to win. All message and data rates apply.

One entry per person per day (24-hour period.)

Entries remain the property of Sponsor and will not be returned or acknowledged.

IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED

One winner will be notified by phone by Sponsor by 12 p.m. PT on February 10, 2014.

Limit one (1) prize per winner per household for this sweepstakes. People who have won any other prizes on ESPNLA 710 within thirty (30) days of entry are not eligible to enter this sweepstakes.

Winner MUST be a member of the ESPNLA 710 Text Club.

Entrants/households who have won any other prizes on ESPNLA 710 within 30 days of entry are not eligible to enter this sweepstakes.
