

OFFICIAL SWEEPSTAKES RULES

"All Star Game" Sweepstakes:

I. SPONSOR

ABC Radio Los Angeles Assets, LLC, licensee of KSPN-AM Los Angeles, Inc., Kia Motors America (Hereinafter collectively referred to as "Sponsor").

II. ELIGIBILITY

Sweepstakes are open to all legal California residents ages 21 years or older at the time of entry.

Entrants must text the keyword "STAR" to shortcode 4-0-7-0-5 to be qualified to win. All message and data rates apply.

One entry per person per day (24-hour period.)

Standard carrier text messaging and data rates may apply. Only texts containing the specified word received within specified time will have a chance to win.
