

OFFICIAL SWEEPSTAKES RULES

ESPNLA Poker Tournament Sweepstakes:

I. SPONSOR

ABC Radio Los Angeles Assets, LLC, licensee of KSPN-AM Los Angeles and Commerce Hotel & Casino, (Hereinafter collectively referred to as "Sponsor").

II. ELIGIBILITY

Sweepstakes are open to all legal California residents ages 21 years or older at the time of entry.

Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for KSPN-AM, its licensee ABC Radio Los Angeles Assets, LLC, Commerce Hotel & Casino, or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the sweepstakes or supplying the prize, and their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, are not eligible to enter or play. "Immediate family members" shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses. "Household members" shall mean people who share the same residence at least three months a year.

From June 6 - 19, 2016, text 'POKER' to 40705 to enter for a chance to win a free seat to the ESPNLA Poker Tournament at Commerce Hotel & Casino on Sunday, June 26th at 12:30 p.m. PT. Limited to ONE (1) entry/person/day.

Sweepstakes is limited to only ONE (1) entry per person per household.

All message and data rates apply. Only texts containing the specified word received by the number specified can win. Sponsor is not responsible for inability of listeners to text within specified time, whether due to busy lines, disconnections, telephone malfunctions or other circumstances.

Sponsor is not responsible for failed, partial or garbled computer transmissions, or for technical failures of any kind, including but not limited to electronic malfunction or damage of any network, hardware or software. If for any reason the contest is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the contest, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the contest. No responsibility is assumed for: any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, providers, computer equipment, or software; or failure of any e-mail or electronic entry to be received on account of technical problems or traffic congestion on the Internet or at any Web-site, or any combination thereof, including any injury or damage to entrant's or any other person's computer related to or resulting from participation in or downloading any materials from this contest.

Due to other programming commitments, there may be a number of dates when KSPN-AM, at its sole discretion will preempt a particular opportunity to enter. The "Poker" call out will be aired a minimum of five times per day between 6 a.m. to 6 p.m. Listeners have the opportunity to enter one time per day during the entry period. In that event, if time permits, the opportunity to enter may be presented at a different hour.

IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED

Three-hundred (300) entries will be selected to play in the ESPNLA Poker Tournament at Commerce Hotel & Casino on Monday, June 20. The selected entrants must arrive at Commerce Hotel & Casino by the start of the ESPNLA Poker Tournament on Sunday, June 26, at 12:30 p.m. PT to qualify to play.

The three-hundred (300) eligible contestants will play a Texas Hold 'Em Poker tournament with a free buy-in and tournament chips. Play goes on as normal with the blinds going up in regular pre-determined intervals and until one player is left with all the chips. Where you are eliminated is where you finish the tournament.

In the event winner is deemed ineligible, fails to comply with sweepstakes and contest procedures, or is not available to claim prize during specified dates, then the prize will be awarded to an alternate winner, time permitting.

Sponsor is not responsible for winner notifications via texting that are the result of texting, computer or transmission errors and may cancel, modify or suspend the sweepstakes based upon any such error without liability at Sponsor's sole discretion. In the event that an error occurs and more than the designated number of prizes are claimed, the designated number of prizes will be awarded in a second round drawing from among eligible claimants.

Odds of winning depend on number of valid entries received.

Final determination of winners is always conditional on verification of eligibility and compliance with all rules and procedures.

V. PRIZE

Three-hundred (300) winners will receive a free spot in the ESPNLA Poker Tournament at Commerce Hotel & Casino on Sunday, June 26, 2016.

One (1) first place winner from the poker tournament will receive \$3,000 and a playing spot worth \$1,000 to a future Commerce poker tournament.

First prize value: approx. \$4,000

One (1) second place winner from the poker tournament will receive \$1,000.

One (1) third place winner from the poker tournament will receive \$500.

One (1) fourth place winner from the poker tournament will receive \$250.

One (1) fifth place winner from the poker tournament will receive \$150.

One (1) sixth place winner from the poker tournament will receive \$100.

All expenses not specifically provided for herein are the winner's sole responsibility. Some restrictions may apply.

Federal, state and local taxes, if any, are the sole responsibility of the winner, who will receive an IRS Form 1099 reflecting the final actual value of any prize valued at \$600 or more.
