

OFFICIAL SWEEPSTAKES RULES

I. SPONSOR

Entrants must text the keyword "LA" to shortcode 4-0-7-0-5 and vote to be qualified to win. All message and data rates apply.

All entries that voted for the team (LAA or LAD) that generated the most votes for that corresponding day (7/28 - 8/1) will be entered into a drawing.

One entry per person per day (10:00 a.m. – 7:00 p.m. PT)
