

## **OFFICIAL SWEEPSTAKES RULES**

### **CLEARWIRE "HAPPY HOUR" SWEEPSTAKES**

#### **I. SPONSOR**

ABC Radio Los Angeles Assets, LLC, licensee of KSPN-AM Los Angeles, and Clearwire Corporation (Hereinafter collectively referred to as "Sponsor").

#### **II. ELIGIBILITY**
