

## **OFFICIAL SWEEPSTAKES RULES**

"See you in London" Sweepstakes:

### **I. SPONSOR**

ABC Radio Los Angeles Assets, LLC, licensee of KSPN-AM Los Angeles, Inc. 800 W. Olympic Blvd. Suite A-200, Los Angeles, CA 90015 (Hereinafter referred to as "Sponsor").

### **II. ELIGIBILITY**

Entrants must be 21 years of age or older at the time of entry and legal U.S. resident of California, who reside in the KSPN-AM listening area, except where prohibited by law.

The **See You in London** Sweepstakes (the "Sweepstakes") begins on **August 21, 2017** and ends on **September 8, 2017**. (the "**Sweepstakes Period**"). Beginning on or around **6:00 AM (PST)** on **Monday August 21<sup>st</sup>, 2017** and ending on or around 5:59 AM (PST) each weekday (the "**Entry Period**") Entrants may enter by sending an Entry by TEXT or EMAIL with the keyword "LONDON" (see details below) for (9) chances to win the grand prize!

Step 1: All entrants must listen to ESPNLA 710 AM during the Sweepstakes Period. The station will announce instructions on-air. Once the listener hears the cue, they may enter by sending a TEXT Entry by texting keyword " LONDON" followed by a [SPACE] and their "FIRST NAME" "LAST NAME" " to 40705 or EMAIL the Entry to [espnmarketing@espn.com](mailto:espnmarketing@espn.com).

Step 2: All entrants must listen for their name to be announced on-air on ESPNLA 710 AM around 8:00 AM PST on the following (9) dates: 8/28/17, 8/29/17, 8/30/17, 8/31/17, 9/1/17, 9/5/17, 9/6/17, 9/7/17, 9/8/17 ("Announcement Dates"). Potential qualifiers will be randomly selected from all valid entries received by 5:59 am PST on Announcement dates. Following their first and last name on-air, Entrant has 20 minutes to call back Sponsor at 877-710-ESPN (3776) to qualify for the grand prize. If entrant fails to call back Sponsor at designated time, a new potential qualifier will be selected the following day.

One entry per person per day (24-hour period) during the Sweepstakes Period, regardless of number of email addresses or cellular phone accounts a person may have. For the purposes of this Sweepstakes, a "weekday" is defined as beginning at 6:00 AM PST and ending the following day at 5:59 AM PST. One (1) Grand Prize winner will be selected on or about **Monday September 11, 2017** by random drawing from all valid qualifiers chosen during the Sweepstakes Period, and will be notified by an ESPNLA710 representative at the phone number and email address provided at the time of the entry. **Potential Grand Prize Winner must respond to the email or phone number provided within 48 hours or prize will be forfeited and awarded to another randomly-selected entrant, time permitting.** All winner's, guest companion and release documents have to be submitted to Sponsor within 72 hours or the prize will be forfeited and awarded to an alternate randomly selected potential grand prize winner, time permitting.
