

## **OFFICIAL SWEEPSTAKES RULES**

"Dream Ticket" Sweepstakes:

### **I. SPONSOR**

ABC Radio Los Angeles Assets, LLC, licensee of KSPN-AM Los Angeles, Toyota Motor Corporation, The Finer Diner Holding Company LLC and its affiliates d/b/a Tom's Urban 24, and Go Viva, LLC (Hereinafter collectively referred to as "Sponsor").

### **II. ELIGIBILITY**

Sweepstakes are open to all legal California residents ages 21 years or older at the time of entry.

Entrants must listen to ESPNLA 710, weekdays (Monday – Friday) from 5 a.m. to 7 p.m. from May 4, 2015 – May 15, 2015.

Every hour we will play the "ping pong" sounder. Once the listener hears the "ping pong" sounder, they must text the keyword "DREAM" to shortcode 40705, the entrant who is determined to have submitted the 710<sup>th</sup> text received will be qualified, pending final verification, to attend our Draft Lottery Watch Party on Tuesday, May 19, 2015 from 3 p.m. to 7 p.m. at Tom's Urban 24 Restaurant on 1011 South Figueroa Street, Los Angeles, CA 90015.

All message and data rates apply. Only texts containing the specified word received by the number specified can win. Sponsor is not responsible for inability of listeners to text within specified time, whether due to busy lines, disconnections, telephone malfunctions or other circumstances.

Due to other programming commitments, there may be a number of dates when KSPN-AM, at its sole discretion will preempt a particular opportunity to enter. In that event, if time permits, the opportunity to enter may be presented at a different hour.

Entries remain the property of Sponsor and will not be returned or acknowledged.

### **IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED**

From May 5 – 8, 2015 and May 11 - 15, 2015 (Monday – Friday only) we will select (14) daily qualifiers who are the 710<sup>th</sup> texter for that particular day.

All the qualifiers will be notified by phone by Sponsor by 12 p.m. PT the following weekday.

On Tuesday, May 19, 2015 ESPNLA will host a Draft Lottery Watch Party at Tom's Urban 24 Restaurant in Los Angeles from 3 p.m. to 7 p.m. All the qualifiers must attend the watch party in its entirety to be qualified to win the Grand Prize and Consolation Prizes. Each qualifier will receive (2) ping pong balls and a ticket all with the same number. Each qualifier will also be allowed to bring one guest who will receive (1) ping pong ball. In the event the guest does not show up, the ping pong ball will be void. All the ping pong balls will be housed in a container. KSPN-AM will randomly choose the ping pong balls from the container to award the grand prize and consolation winners.

Entrants can also qualify to win by attending the Draft Lottery Watch Party on the day of the event. All entrants who show up will receive (1) ping pong ball.

There will be a limit of 500 ping pong balls that KSPN-AM will distribute. Once the 500 ping pong balls are distributed the event will be closed to the public.

Limit one (1) prize per winner per household for this sweepstakes. People who have won any other prizes on ESPNLA 710 within thirty (30) days of entry are not eligible to enter this sweepstakes.

Entrants/households who have won any other prizes on ESPNLA 710 within 30 days of entry are not eligible to enter this sweepstakes.

Odds of winning depend on number of valid entries received and the number of qualifiers who attend the Draft Lottery Watch Party.

Final determination of winners is always conditional on verification of eligibility and compliance with all rules and procedures.

## **V. PRIZES**

Consolation Prizes:

(3) consolation winners will receive (2) tickets to a Los Angeles Lakers home game at Staples Center during the 2015-16 season.

Approximate retail value of each consolation prize: \$100

Grand Prize:

One (1) grand prize winner will be selected from all the qualified entries (ping pong balls) and will receive the following

One Trip for two (2) to any sporting event in the United States of their choosing within 12 months of being awarded the prize.

- o Round trip coach class airfare for two (2) from a Los Angeles area airport to an airport in the United States near the destination city
- o Hotel accommodations (one room, double occupancy)
- o Two (2) Game tickets (general seating)

Approximate retail value of Grand Prize: \$5,000.
