

OFFICIAL SWEEPSTAKES RULES

ESPNLA Poker Tournament Sweepstakes:

I. SPONSOR

ABC Radio Los Angeles Assets, LLC, licensee of KSPN-AM Los Angeles and Gardens Casino, (Hereinafter collectively referred to as "Sponsor").

II. ELIGIBILITY

Sweepstakes are open to all legal California residents ages 21 years or older at the time of entry.

Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for KSPN-AM, its licensee ABC Radio Los Angeles Assets, LLC, Gardens Casino, or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the sweepstakes or supplying the prize, and their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, are not eligible to enter or play. Standard carrier text messaging and data rates may apply. Only texts containing the specified word received within specified time will have a chance to win. Sponsor is not responsible for inability of listeners to text within specified time, whether due to busy lines, disconnections, telephone malfunctions or other circumstances. By entering via text, you grant sponsor your consent to contact you at the phone number or email address used for entry should you be selected as a daily qualifier. Should there be a dispute about the identity of a daily winner, the prize will be awarded to the owner of the phone or email account used to submit the winning entry.

IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED

Three-hundred (300) entries will be selected to play in the ESPNLA Poker Tournament at Gardens Casino on Monday, February 1, 2015 and notified via mobile text messaging. The selected entrants must reply back with their name and email address via email at promotions@710espn.com to confirm their spot.

The three-hundred (300) eligible contestants will play a Texas Hold 'Em Poker tournament with a free buy-in and tournament chips. Play goes on as normal with the blinds going up in regular pre-determined intervals and until one player is left with all the chips. Where you are eliminated is where you finish the tournament.

In the event winner is deemed ineligible, fails to comply with sweepstakes and contest procedures, or is not available to claim prize during specified dates, then the prize will be awarded to an alternate winner, time permitting.

Sponsor is not responsible for winner notifications via texting that are the result of texting, computer or transmission errors and may cancel, modify or suspend the sweepstakes based upon any such error without liability at Sponsor's sole discretion. One (1) first place winner from the poker tournament will receive \$3,000.

One (1) second place winner from the poker tournament will receive \$500.

One (1) third and fourth place winner from the poker tournament will receive \$300 each.

One (1) fifth, sixth and seventh place winner from the poker tournament will receive \$200 each.

One (1) Eighth, Ninth and Tenth place winner from the poker tournament will receive \$100 each.

All expenses not specifically provided for herein are the winner's sole responsibility. Some restrictions may apply.

Federal, state and local taxes, if any, are the sole responsibility of the winner, who will receive an IRS Form 1099 reflecting the final actual value of any prize valued at \$600 or more.
