

OFFICIAL SWEEPSTAKES RULES

ESPNLA Poker Tournament Sweepstakes:

I. SPONSOR

ABC Radio Los Angeles Assets, LLC, licensee of KSPN-AM Los Angeles and Gardens Casino, (Hereinafter collectively referred to as "Sponsor").

II. ELIGIBILITY

Sweepstakes are open to all legal California residents ages 21 years or older at the time of entry.

Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for KSPN-AM, its licensee ABC Radio Los Angeles Assets, LLC, Gardens Casino, or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the sweepstakes or supplying the prize, and their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, are not eligible to enter or play. "Immediate family members" shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses. "Household members" shall mean people who share the same residence at least three months a year.

III. HOW AND WHEN TO ENTER

NO PURCHASE NECESSARY.

From February 20, 2014 to March 7, 2014, text 'POKER' to 40705 to enter for a chance to win a free seat to the ESPNLA Poker Tournament at Gardens Casino on Thursday, March 13th at 6:30 p.m. PT. Limited to ONE (1) entry/person/day.

Entries remain the property of Sponsor and will not be returned or acknowledged.

Sweepstakes is limited to only ONE (1) entry per person per household.

Standard carrier text messaging and data fees may apply. By entering via text you grant Sponsor your consent to call your cell phone should you be selected as a potential winner.

IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED

Three-hundred (300) entries will be selected to play in the ESPNLA Poker Tournament at Gardens Casino on Thursday, March 13, 2014. The selected entrants must arrive at Gardens Casino by the start of the ESPNLA Poker Tournament on Thursday, March 13 at 6:30 p.m. PT to qualify to play.

The three-hundred (300) eligible contestants will play a Texas Hold 'Em Poker tournament with a free buy-in and tournament chips. Play goes on as normal with the blinds going up in regular pre-determined intervals and until one player is left with all the chips. Where you are eliminated is where you finish the tournament.

In the event winner is deemed ineligible, fails to comply with sweepstakes and contest procedures, or is not available to claim prize during specified dates, then the prize will be awarded to an alternate winner, time permitting.

Sponsor is not responsible for winner notifications via texting that are the result of texting, computer or transmission errors and may cancel, modify or suspend the sweepstakes based upon any such error without liability at Sponsor's sole discretion. In the event that an error occurs and more than the designated number of prizes are claimed, the designated number of prizes will be awarded in a second round drawing from among eligible claimants.

Odds of winning depend on number of valid entries received.

Final determination of winners is always conditional on verification of eligibility and compliance with all rules and procedures.

V. PRIZE

Three-hundred (300) winners will receive a free spot in the ESPNLA Poker Tournament at Gardens Casino on Thursday, March 13, 2014.

One (1) first place winner from the poker tournament will receive \$3,000.

One (1) second place winner from the poker tournament will receive \$500.

One (1) third and fourth place winner from the poker tournament will receive \$300 each.

One (1) fifth, six and seventh place winner from the poker tournament will receive \$200 each.

One (1) Eight, Ninth and Tenth place winner from the poker tournament will receive \$100 each.

All expenses not specifically provided for herein are the winner's sole responsibility. Some restrictions may apply.

Federal, state and local taxes, if any, are the sole responsibility of the winner, who will receive an IRS Form 1099 reflecting the final actual value of any prize valued at \$600 or more.
