

## **OFFICIAL SWEEPSTAKES RULES**

"SLP" Sweepstakes

### **I. SPONSOR**

ABC Radio Los Angeles Assets, LLC, licensee of KSPN-AM Los Angeles and the California State Lottery (Hereinafter collectively referred to as "Sponsor").

ABC Radio Los Angeles Assets, LLC, licensee of KSPN-AM will be the "Administrator" and execute the sweepstakes and fulfill the grand prize.

### **II. ELIGIBILITY**

Sweepstakes are open to all legal California residents' ages 18 years or older at the time of entry, except as specified in this section.

Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for KSPN-AM or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the sweepstakes or supplying the prize, and their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, are not eligible to enter or play. ### **III. HOW AND WHEN TO ENTER**

#### **NO PURCHASE NECESSARY.**

Entrants must listen to ESPNLA 710, starting at 12:30 pm PST on February 26, 2017 through 11:59pm PST on March 19, 2017, for the promotional announcement with the cue to text "SLP" to 4-0-7-0-5.

Once the listener hears the announcement, they must text the designated keyword to shortcode 40705 or email the keyword to [promotions@710espn.com](mailto:promotions@710espn.com) within 30 minutes to be entered into the potential qualifier pool. One entry per person per day (2/26 – 3/19).

Only texts to the specified number can win. Standard text and data rates may apply; please see your carrier agreement for any costs associated with text messaging. All entrants must have a text messaging two-way capable handset and digital service in order to enter the Sweepstakes using the text messaging method. Prize will be awarded to the name corresponding to the phone number from which the text message originated. Please consult your wireless service provider regarding your pricing plan. Not all cellular phone providers carry necessary service to participate. Check your phone capabilities for specific text messaging instructions. By entering via text or providing your phone number in an email entry, you grant Administrator or their agency your consent to call your cell phone should you be selected as a potential winner, as well as to acknowledge a text entry by return text.

Only emails to the specified email address can win. Mass entries or entries generated by a script, macro, or use of automated methods will be disqualified. If for any reason the sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the sweepstakes, Administrator reserves the right at its discretion to determine the winner using all non-suspect eligible entries received up to the time of cancellation. Administrator is not responsible for failed, partial, delayed or garbled computer transmissions, or for technical failures of any kind in connection with entries or the entry process, including but not limited to electronic, malfunction or damage of any network, hardware or software. In the event of a dispute over an electronic entry, prize will be awarded to the authorized subscriber of the e-mail account, not the name on the entry form. All entries become the sole property of the Administrator and receipt of entries will not be acknowledged or returned.

### **IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED**

On or about March 20, 2017, we will randomly select (1) potential grand prize winner from all the qualified text and email entries combined. Potential winner will be notified by phone or email by Administrator by approximately 10:00 a.m. PT on or about March 20, 2017.

Limit one (1) prize per household for this sweepstakes. Entrants/households who have won any other prizes on ESPNLA 710 within 30 days of entry are not eligible to enter this sweepstakes.

In the event winner is deemed ineligible, fails to comply with sweepstakes procedures, then an alternate winner will be selected at random from remaining valid entries.

Final determination of winner is always conditional on verification of eligibility and compliance with all rules and procedures.

## **V. PRIZES**

One (1) Grand Prize winner will receive:
