

## **OFFICIAL SWEEPSTAKES RULES**

"Goal Getaway" Sweepstakes

### **I. SPONSOR**

ABC Radio Los Angeles Assets, LLC, licensee of KSPN-AM Los Angeles, Smart and Final Inc., and Shasta Beverages Inc., (Hereinafter collectively referred to as "Sponsor").

### **II. ELIGIBILITY**

Sweepstakes are open to all legal California residents in the following counties: Santa Barbara, Ventura, Kern, Los Angeles, Orange County, San Bernardino, Riverside and San Diego, age 18 years or older at the time of entry.

Once the listeners hear the designated keyword, they must text it to shortcode "40705." All the verified text entries will be entered to win the Grand Prize and Consolation Prizes.

Winners will be notified by phone by Sponsor on or about the week of July 14-18, 2014. Response to winner notification must be received by Sponsor within three (3) business days or the prize will be awarded to an alternate winner, time permitting.

Entrants who have won any other prizes on ESPNLA 710 within 30 days of entry are not eligible to win this sweepstakes.
