

OFFICIAL SWEEPSTAKES RULES

I. SPONSOR

Entrants must text the keyword "BASEBALL" to shortcode 4-0-7-0-5 and answer the multiple choice question of the day correctly to be qualified to win. All message and data rates apply.

All correct entries from each week (7/11; 7/18; 7/25) will be entered into a drawing.

One entry per person per day (10:00 a.m. – 7:00 p.m. PT)
