

## **OFFICIAL SWEEPSTAKES RULES**

"Summer Ballpark Tour" Sweepstakes:

### **I. SPONSOR**

ABC Radio Los Angeles Assets, LLC, licensee of KSPN-AM Los Angeles, Nexen Tire and Southern California Chevrolet Dealers.(Hereinafter collectively referred to as "Sponsor").

### **II. ELIGIBILITY**

Once the listener hears the "baseball" sounder, they must text the keyword "BASEBALL" to shortcode 40705 within 30 minutes. Entrants will receive one confirmation text message acknowledging entry was received by ESPNLA.

As an alternate means of entry, listeners can email [promotions@710espn.com](mailto:promotions@710espn.com) within 30 minutes of hearing the "baseball" sounder on ESPNLA 710.

All message and data rates apply. Only texts containing the specified word received by the number specified can win. Sponsor is not responsible for inability of listeners to text within specified time, whether due to busy lines, disconnections, telephone malfunctions or other circumstances.

In that event, if time permits, the opportunity to enter may be presented at a different hour.
