NARRATIVE:

ON 10-20-2010 AT APPROX 4:47AM I OFFICER SILCOX OFFICER FLECK AND OFFICER LY WERE DISPATCHED TO THE CORNER OF BROAD RIPPLE AVE AND COLLEGE AVE ON THE REPORT OF A SUSPICIOUS PERSON. THE CALLER STATED THAT A WHITE MALE WITH NO SHIRT WAS STANDING BY HER VEHICLE. WHEN HE WAS CONFRONTED HE TOOK OF RUNNING WEST ON BROAD RIPPLE AVE. UPON OFFICER LY'S ARRIVAL HE OBSERVED A W/M WITH NO SHIRT STANDING ON THE SOUTH WEST CORNER OF BROAD RIPPLE AND COLLEGE AVE. IT WAS AT THIS TIME MYSELF AND OFFICER FLECK ARRIVED ON SCENE AND OBSERVED THE W/M (LATER IDENTIFIED OFF OF A PA DRIVERS LICENSE AS A PATRICK MCAFEE) SITTING ON THE GROUND. WHEN I SPOKE WITH MR. MCAFEE HE HAD A STRONG ODOR OF ALCOHOLIC BEVERAGE COMING FROM HIS BREATH HIS EYES WERE WATERY RED AND BLOOD SHOT, AND HIS SPEECH WAS SLURRED. I ALSO NOTICED THAT MR. MCAFEE WAS SOAKING WET. I ASKED MR. MCAFEE IF HE WAS SWIMMING IN THE CANAL, AND HE STATED "I AM NOT SURE". OFFICER LY ASKED MR. MCAFEE HOW HE GOT ALL WET AND HE SAID "IT WAS RAINING" I ASKED MR. MCAFEE WHERE HIS SHIRT WAS AND HE SAID "IT IS IN THE WATER". I ASKED MR. MCAFEE HOW HE WAS GETTING HOME, AND HE STATED "I AM WAITING FOR A FRIEND TO COME GET ME". I ASKED MR. MCAFEE WHERE HIS FRIEND WAS, AND HE STATED "I AM GETTING A CAB". I SAID THERE WERE NO CABS ON BROAD RIPPLE AVE, AND THAT THEY NORMALLY ARE NOT UP HERE THIS LATE. I ASKED MR. MCAFEE IF HE KNEW WHAT TIME IT WAS AND HE STATED 3:40AM. I ASKED MR. MCAFEE IF HE WANTED ME TO CALL A CAB, AND HE STATED THAT "I WILL WALK HOME. I TOLD MR. MCAFEE THAT HE CANNOT WALK HOME AND HE SAID "WHY CAN'T I WALK HOME. I TOLD MR. MCAFEE THAT HE WAS DRUNK AND IT IS AND IT WAS NOT SAFE. MR. MCAFEE STATED "I KNOW I AM DRUNK, BUT DOES THAT MEAN I CANNOT WALK HOME". I ASKED MR. MCAFEE HOW MUCH HE HAD TO DRINK AND HE SAID "A LOT CAUSE I AM DRUNK". I ASKED MR. MCAFEE WHERE HE WAS DRINKING AND HE SAID "IN BROAD RIPPLE" AT THAT TIME I OFFERED MR. MCAFEE A PBT AND HE SUBMITTED AND BLEW A .15. I HAD MR. MCAFEE STAND UP AND HAD TROUBLE STANDING UP AND OFFICER FLECK HAD TO ASSIST HIM UP. I THEN PLACED MR. MCAFEE UNDER

ARREST FOR PUBLIC INTOXICATION. I CALLED THE FEMALE WHO CALLED THE POLICE AND SHE STATED THAT SHE WAS NORTH BOUND ON COLLEGE AVE STOPPED AT THE RED LIGHT AT BROAD RIPPLE AVE. THE CALLER STATED THAT MR. MCAFEE STARTED TO APPROACH HER CAR. THE CALLER STATED THAT IT LOOKED AS IF HE WAS COLD AND WAS GOING TO TRY AND GET IN HER CAR. THE CALLER STATED SHE GOT SCARED AND HAD TO RUN THE RED LIGHT TO GET AWAY. THAT IS WHEN THE CALLER STATED SHE CALLED 911. MR. MCAFEE WAS TRANSPORTED TO APC VIA THE WAGON.
