CHAMPIONSHIP SITE

The University of Alabama Harry Pritchett Cross Country Course

Course Description

Course is run entirely on grass and over rolling hills. It is approximately 410 meters from the start to the first turn. There is approximately a 350 meter straight run-in to the finish.

See **Appendix C** for map to course. See **Appendix E** for Women's 6k Course Map See **Appendix F** for Men's 8k Course Map

COURSE MARKINGS

The course will be painted with white lines as well as flagged and marked appropriately. Kilometers and miles will be marked for both the men's and women's distances. The following markers will differentiate kilometers and miles for the women and men:

Women's 6k

Kilometers: White diamond with red numbers Miles: Red square with white numbers

Men's 8k

Kilometers: Blue diamond with white numbers Miles: White square with blue numbers

There will split times given at the 2K and 4K markers for the women and the 2k, 4K and 6K for the men. Live splits will be available for both races by clicking on the "Live Results" timing link located on the SEC championship website.

BOX DRAW

The SEC office will conduct a blind draw the day prior to the championships conference call to assign starting boxes. Starting box assignments will be given during the conference call. The boxes will be numbered 1-14 starting on the left while facing the course. Each box will be wide enough for a minimum of 5 runners.

STUDENT-ATHLETE CHECK-IN

All student-athletes must check-in with the Clerk of the Course. Check in will be available at 7:00 a.m. and will stay open until 10 minutes prior to the start of each perspective race. Bibs and timing chips will be checked at the Clerk of the Course.

FINISH LINE PROCEDURES

There will be two chip timing mats at the finish line. Runners should continue racing past both mats and into the corral. Runners do not need to maintain their order in the corral. Once in the corral the runner's timing chips will be removed and they will have water and trainers available. Runners MUST have their timing chips removed before leaving the corral.

There will be two Finish lynx cameras for primary timing and another two Finish lynx cameras for back-up timing.

Official results will be posted after the finish is verified by Finish lynx cameras and signed off by the Meet Referee and the NCAA official on site.

There will be an additional mat 100 meters prior to the finish line. This mat will be used to assist in announcing the athletes as they approach the finish. Runners should be instructed that this mat is not the finish.

COACHES MEETING

The coaches meeting will be at 3:00 p.m. (CST) at the Harry Pritchett Cross Country Course Thursday, October 30. All race day procedures will be addressed.

DECLARATIONS

Final declarations will be completed at the coaches meeting on Thursday, October 30 at 3:00 p.m. (CST).

ELIGIBILITY

All competitors must be certified eligible by their institution as required by the SEC office, prior to participating in the SEC Championships.

ENTRIES & RESULTS

Dan Passen with Xpress Timing will manage the timing and scoring of the 2014 SEC Cross Country Championships. Online entries will be handled by Direct Athletics and will open on Monday, October 6 and will close on Wednesday, October 22 at 6:00 p.m. (CST). Preliminary entries will be posted at the SEC Cross Country Championships page at www.rolltide.com on Monday, October 27 by noon (CST). In addition, starting box assignments will be posted after the completion of the coaches' conference call on October 27 on the same site. Results will be

posted at the conclusion of the meet at the competition site and will be available to teams at the awards area after the meet as well as at www.rolltide.com. Contact Doug Walker at the University of Alabama for more information at dwalker@ia.ua.edu.

INCLEMENT WEATHER PROCEDURES

Lightning Policy

Following NCAA protocol, we will be using WeatherSentry online lightning detection and weather monitoring system. Once lightning enters the 30 mile radius of competition, we will begin preparations to protect the student-athletes and spectators. Once lightning enters an eight mile radius of our site, competition must stop and student-athletes and spectators will be moved to safe areas. We will not begin any activity until 30 minutes have passed since the last lightning strike inside the warning ring.

Shelter Locations

There is no available shelter at the course. Buses and personal vehicles will be used as shelter in case of inclement weather.

Media Work Room

There is no formal media work room at the Harry Pritchett Running Course, but there will be a tent for working SIDs and media. However, there is no available power. We encourage any media or SIDs covering the event to write full stories either from their hotel rooms after the event or, if needed, we can provide room for you to work back at our media work room in Coleman Coliseum on campus after the race.

Mixed Zone

There will be a mixed zone tent adjacent to the finish tent adjacent to the finish line for interviews with individual winners immediately following each race, along with the winning teams' head coaches when team winners are officially announced.

All credentialed media and each institution's media relations contacts will automatically be added to the 2014 SEC Cross Country Championships distribution list.

MEET PACKETS

Team packets will include manuals and regulations, event schedule and agenda, championship maps, box assignments, parking passes, timing chips, bib numbers, championship competitors list, protest form, emergency/inclement weather procedures, food and hospitality information, ballot for awards, championship t-shirts, safety pins, and a quick reference guide. Packets will be distributed at the coaches meeting at 3:00 p.m. (CST) on Thursday, October 30.

SCORING/AWARDS

Each team may have ten competitors, the first five finishers of each team will constitute the team score, with runners six and seven displacing. Any remaining student-athletes will not influence scoring in any way. However, they will receive an official time.

The SEC Championships Award Ceremony will take place at the awards podium at approximately 11:15 a.m. (CST) on Friday, October 31. The following individuals will be recognized:

- Men's & Women's Conference Champion (trophies presented during ceremony)
- Men's & Women's Top 3 Place Finishers (medallions presented during ceremony)
- Men's & Women's 1st Team All-SEC (finishers 1-7, awards sent post championships)
- Men's & Women's 2nd Team All-SEC (finishers 8-14, awards sent post championships)
- Men's & Women's All-Freshman Team (top 7 finishers, awards sent post championships)

Take McFarland Blvd. to 15th St. East. Turn onto 15th St. East (Veterans Memorial Parkway) towards VA Hospital. Approx 2.5 miles exit to right at split (towards VA Hospital and UA Arboretum) and then an immediate left to UA Arboretum. Cross over Loop Road. One way signage will force you to turn left (again towards UA Arboretum). After the left turn and before crossing back under Veterans Memorial Parkway the road will again split. Take the right towards UA Arboretum. The Harry Pritchett Cross Country Course is at the top of hill.

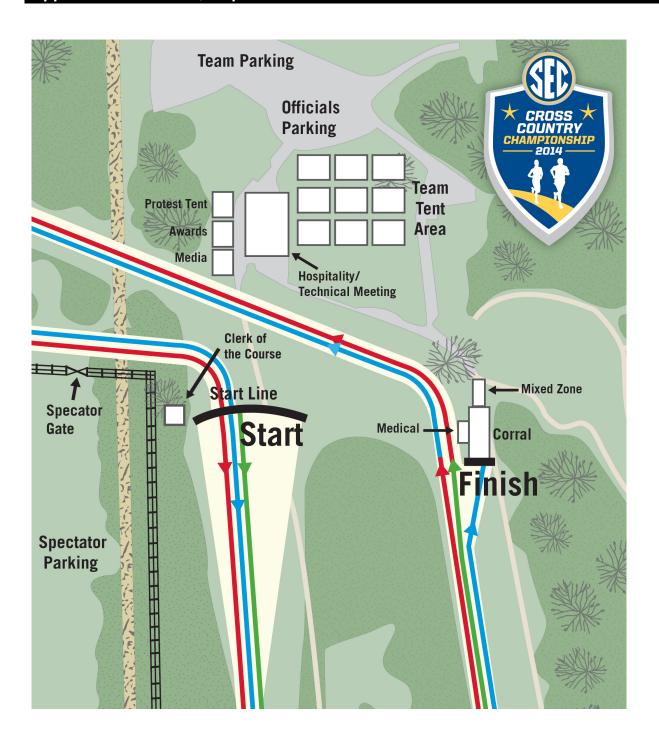
Appendix E: Women's 6,000 Meter Course Map
