## 2017 Soccer Schedule Parameters

(Approved 3.16.16)

1. Teams will play a 10 -match schedule - every team in division and four revolving opponents from the other division. For future schedules, the teams not played in the other division will be designated opponents with the remaining opponents randomly selected.
2. Match schedule starts on Thursday, September $14^{\text {th }}$ and ends on Thursday, October $26^{\text {th }}$ with a 1-2-1-2-1-2-1 rotation.
3. On weekends where two matches are scheduled, games will be played Thursday and Sunday. Preferably, the two match weekends will be "split" travel weekends.
4. On single weekends, games can be played Thursday, Friday, Saturday or Sunday depending on television, campus events, budgets, and missed class time. Each team administrator must approve the day change.
5. The conference office will develop a four-year 10-game schedule to minimize anomalies or disadvantages the schedule/parameters create.
6. No more than 3 consecutive away games.
7. Potentially, one match per week shifted to Friday to accommodate television. Sunday teams shall not be competitively disadvantage more than once during the season by a team playing a Friday contest.
8. For television purposes, WEEKDAY MOVES - Any date changes moving a weekend (Fri-Sun) competition to a weekday will adhere to the following guidelines:

- No road team will be asked to move from a weekend (Fri-Sun) competition to a weekday (Mon-Thurs) more than two times in a particular season.
o No home team will be asked to move from a weekend (Fri-Sun) competition to a weekday (Mon-Thurs) more than two times in a particular season.
o Weekday to weekday (i.e. Wednesday to Tuesday) and Saturday to Friday moves are exempt from this scheduling parameter.
- SUNDAY MOVES - Any date changes moving a Fri/Sat competition to Sunday will adhere to the following guidelines:
o No road team will be asked to move from a Fri/Sat competition to a Sunday competition for television more than three times in a particular season.
o No home team will be asked to move from a Fri/Sat competition to a Sunday competition for television more than three times in a particular season."
